\*This Certificate changes the place of use of Permit 47592, which changed the point of diversion and place of use of a portion of Permit 46840, which changed the point of diversion and place of use of a portion of Permit 35794, therefore, the date of priority remains the same as Permit 35794.

This Certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources and the total combined duty of water for any certificates issued under Permits 48205, 48206, 48207, 48418, 48419, 48420 and 48421 shall not exceed 2,052.1 acre-feet annually.

The total combined duty and diversion rate for any certificates issued under Permits 48418 and 48419 shall not exceed 386.8 acre-feet annually and 1.23 c.f.s.
