CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert E. Morley, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and irrigation system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

SW1/4 NW1/4 Section 4, T.30N., R.56E.,
M.D.B.&M. or at a point from which the NW
corner of said Section 4 bears N 1' 00' 00"
W., a distance of 2,574.0 feet situated in
Elko County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

The total combined duty of water under this certificate and any certificate issued under Permit 54173, shall not exceed 1,440 acre-feet annually.

The place of use under this Certificate and Permit 54173 is limited to the irrigation of 480 acres.


This Certificate is supplemental to a portion of Humboldt River Decree, Proof No. 00654, within the NE1/4 NE1/4 and SE1/4 NE1/4 Section 5, T.30N., R.56E., M.D.B.&M.

This Certificate is issued subject to the terms of the Permit and with the understanding that the total duty of water shall not exceed 3.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
