WHEREAS, David A. Donnelly, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source (Well No. 7A) (Las Vegas Artesian Basin) through a drilled well, pump and distribution system for Municipal and Domestic purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$  NE $\frac{1}{4}$  Section 31, T.20S., R.61E., M.D.B.&M.  
or at a point from which the E $\frac{1}{4}$  corner of said  
Section 31 bears S. 47° 12' 59" E., a distance  
of 404.0 feet situated in Clark County, State  
of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	0.10 c.f.s. but not to exceed 29.62 acre-feet annually

Date of priority of appropriation:	*January 28, 1955

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 932 feet deep, 20 inch casing, via a pump with a 250 H.P. electric motor to pipelines and reservoirs, thence through a distribution system to the area included within the boundaries of the Las Vegas Valley Water District as denoted by Chapter 167, Statutes of Nevada, 1947, as it now exists or as it may hereafter be amended for municipal and domestic purposes.



The total combined rate of diversion and the total duty of water granted under Permit 10867, Certificate 3088, Permit 28056, Certificate 9354, Permit 28057, Certificate 9355, Permit 28058, Certificate 9357 and any certificates issued under Permits 55022, 55023 and 55024 shall not exceed 1.594 c.f.s. and 226.81 million gallons annually, respectively.

This certificate is issued subject to the terms of the permit.
