CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George Lindesmith, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from the Truckee River (Steamboat Ditch) through headgates, ditches and ponds for Recreation and Domestic purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 31, T.19N., R.18E., M.D.B.&M.
or at a point from which the SE corner of said
Section 31 bears S. 62° 04' E., a distance of
3,195.0 feet (Steamboat Ditch) situated in
Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	White Pine Lumber Co.
Source:	the Truckee River (Steamboat Ditch)
Manner of Use:	Recreation and Domestic
Amount of appropriation:	0.5835 c.f.s. but not to exceed 191.34 acre-feet as decreed
Period of use:	as decreed
Date of priority of appropriation:	*as decreed

Description of the works of diversion, manner and place of use:

Water is diverted by means of 4 headgates on the Steamboat Ditch, via ditches and natural channels to numerous ponds with a total surface area of 2.56 acres, and landscaped areas adjacent to the ditches and channels for recreation and domestic purposes located in the W $\frac{1}{2}$ W $\frac{1}{2}$, Section 21; SE $\frac{1}{4}$, Section 20; N $\frac{1}{2}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 29, T.19N., R.19E., M.D.B.&M.


This certificate is issued supplemental to Permit 49296.

*This certificate changes the place of use of a portion of Permit 24615, Certificate 7908, which changed the manner and place of use of Truckee River Decree Equity Docket No. A3 Claim No. 65 (723), therefore, the date of priority remains the same as Claim No. 65 (723).

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
