CERTIFICATE OF APPROPRIATION OF WATER**

**WHEREAS**, Wallace T. Boundy, Agent, has presented to the State Engineer of the State of Nevada, Proof of Application of Water to Beneficial Use, from an underground source, through a drilled artesian well and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

**SW<sup>1</sup>/<sub>4</sub> NW<sup>1</sup>/<sub>4</sub> Section 29, T.11N., R.43E., M.D.B.&M., or at a point from which the W<sup>1</sup>/<sub>4</sub> corner of said Section 29 bears S. 55° 29' W., a distance of 1,513.66 feet situated in Nye County, State of Nevada.**

**Under the provisions of NRS 533.425**, the State Engineer has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:


The total combined duty of water under any certificates issued under Permits 16866, 18840, 41151 and 41152 shall not exceed 404.48 acre-feet annually.
