CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Greg R. Doubek, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source (PW 25) through a drilled well, pump and distribution system for Dewatering purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 21, T.40N., R.35E., M.D.B.&M.
or at a point from which the S $\frac{1}{4}$ corner of said
Section 21 bears S. 17° 56' 49" E., a distance
of 2,190.6 feet situated in Humboldt County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Nevada Gold Mining, Inc.
Source: Underground (PW 25)
Manner of Use: Dewatering
Amount of appropriation: *0.82 c.f.s. **
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: ***June 24, 1985

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 735 feet deep, 16 inch casing, via a 100 H.P. submersible pump through 570 feet of 8 inch pipe and 7,860 feet of 18 inch pipe to a discharge pond, which is the beginning of a 4,300 foot canal for dewatering purposes in all of Sections 16 and 21, T.40N., R.35E., M.D.B.&M.

*This diversion rate of 0.82 c.f.s. is for dewatering, which it and its associated duty terminates when the need ceases.

**The total diversion rate under any certificates granted under Permits 50387, 50876, 50878, 50879, 50881, 50882, 50883, 50885, 50886, 50887, 50888, 51284, 51449, 51450, 51772, 51822, 51823, 51824, 51825, 51826 and 52340 shall not exceed 32.0 c.f.s.


This certificate is by nature of its activity a temporary use and any application to change the manner of use granted under this certificate will be subject to additional determination and evaluation with respect to the permanent effects on existing rights and the resource within the ground water basin.

***This certificate changes the point of diversion of Permit 50884, which changed the point of diversion of a portion of Permit 49767, which changed the point of diversion of a portion of Permit 49157, therefore, the date of priority remains the same as Permit 49157.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
