CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, John H. Milton III, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

NW¼ NW¼ Section 16, T.41N., R.28E., M.D.B.&M. or at a point from which the NW corner of said Section 16 bears N. 13° 26' W., a distance of 538.0 feet situated in Humboldt County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Ken H. Earp
 Source: Underground
 Manner of Use: Irrigation and Domestic
 Amount of appropriation: *1.585 c.f.s. but not to exceed **1,147.49 acre-feet annually
 Period of use: January 1st to December 31st of each year
 Date of priority of appropriation: ***June 15, 1977

*The total combined rate of diversion and duty of water under this certificate and any certificate issued under Permit 46131 is limited to 3.17 c.f.s. and 1,400.8 acre-feet per annum, respectively.


**The total combined duty of water under Proof 02241 (Bartlett Creek Decree), Permit 1692, Certificate 253, and any certificates issued under Permits 30331, 45486, 45487 and 46131 shall not exceed 2,302.59 acre-feet annually.

***This certificate changes the point of diversion of Permit 32093, therefore, the date of priority remains the same as Permit 32093.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.6 acre-feet per acre per annum from any/and or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
