CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, D. G. Barneby, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Industrial (cooling) purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 9, T.14S., R.65E., M.D.B.&M.
or at a point from which the W $\frac{1}{4}$ corner of
Section 16, T.14S., R.65E., M.D.B.&M. bears S.
02° 44' 22" W., a distance of 3491.30 feet
situated in Clark County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	Corporation of the Presiding Bishop of the Church of Jesus Christ of the Latter Day Saints
Source:	Underground
Manner of Use:	Industrial (cooling)
Amount of appropriation:	*0.302 c.f.s. but not to exceed **65.0 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	***April 28, 1965

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well 110 feet deep, 16 inch casing, via a deep well pump equipped with a 60 H.P. motor through a pipeline to the Reid Gardner Station Unit No. 4 for industrial (cooling) within the SW $\frac{1}{4}$ and the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 5, T.15S., R.66E., M.D.B.&M.

*The total combined rate of diversion granted under this certificate and any granted under Permit 50724, 50726, 50727, 50728, 50729 and 50730 is limited to 2.932 c.f.s.

**The total combined duty of water under this certificate and any issued under Permits 50723, 50724, 50726, 50727, 50728, 50729, 50730, 50731, 50732 and 50733 shall not exceed 2329.55 acre-feet annually.

***This certificate changes the place of use and manner of use of Permit 26313, Certificate 10948, which changed the point of diversion and place of use of a portion of Permit 22559, Certificate 9606, therefore, the date of priority remains the same as Permit 22559, Certificate 9606.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
