CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Ernest E. Muller, Sr., Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

SW 1/4 NE 1/4 Section 12, T.32N., R.60E., M.D.B.&M. or at a point from which the NE corner of said Section 12 bears N. 48' 51' E., a distance of 2,351.5 feet situated in Elko County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Ramona W. Dahl
Source: Underground
Manner of Use: Irrigation and Domestic
Amount of appropriation: 2.20 c.f.s. but not to exceed 640.0 acre-feet annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: \*June 30, 1977


26.0 acres in the NW 1/4 NW 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
29.0 acres in the NE 1/4 NW 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
25.0 acres in the NW 1/4 NE 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
26.0 acres in the SW 1/4 NW 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
29.0 acres in the SE 1/4 NW 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
25.0 acres in the SW 1/4 NE 1/4 Section 12, T.32N., R.60E., M.D.B.&M.
160.0 Acres Total

\*This certificate changes the point of diversion and place of use of Permit 32487, therefore, the date of priority remains the same as Permit 32487.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
