CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard W. Arden, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source Well #2 through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 24, T.3S., R.54E., M.D.B.&M.
or at a point from which the SW corner of said
Section 24 bears S. 07° 50' 02" W., a distance
of 2,948.15 feet situated in Lincoln County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

31.0 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 24, T.3S., R.54E., M.D.B.&M.
27.0 acres in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 24, T.3S., R.54E., M.D.B.&M.
32.0 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$ Section 24, T.3S., R.54E., M.D.B.&M.
90.0 Acres Total

*The total combined rate of diversion granted under this certificate and any certificates granted under Permits 36442 and 36443 is limited to 2.11 c.f.s.

**The water under this certificate and any certificates issued under Permits 36442 and 36443 is commingled and that the total duty of water shall not exceed 511.21 acre-feet annually for the irrigation of 125 acres within the NW $\frac{1}{4}$ of Section 24, T.3S., R.54E., M.D.B.&M.


***This certificate changes the point of diversion and place of use of a portion of Permit 19172, Certificate 6408, therefore, the date of priority remains the same as Permit 19172, Certificate 6408.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
