CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard W. Arden, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source Well #8 through a drilled well, pump and distribution system for Irrigation purposes. The point of diversion of water from the source is as follows:

SW 1/4 SE 1/4 Section 5, T.4S., R.55E., M.D.B.&M. or at a point from which the S 1/4 corner of said Section 5 bears S. 71' 14' 17" W., a distance of 359.70 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Penoyer Farms, Ltd.

Source: Underground Well #8

Manner of Use: Irrigation

Amount of appropriation: *2.39 c.f.s. but not to exceed **929.0 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: ***November 14, 1960

Description of land to which the water is appurtenant:

30.2 acres in the NW 1/4 SE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
 31.3 acres in the NE 1/4 SE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
 31.9 acres in the SW 1/4 SE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
 31.6 acres in the SE 1/4 SE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
 28.8 acres in the SW 1/4 NE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
32.0 acres in the SE 1/4 NE 1/4 Section 5, T.4S., R.55E., M.D.B.&M.
 185.8 Acres Total

*The total combined rate of diversion granted under this certificate and any granted under Permits 36454, 36456 and 36457 is limited to 3.73 c.f.s.

**The water under this certificate and any certificates issued under Permits 36454, 36456 and 36457 is commingled and that the total combined duty of water shall not exceed 1,250.0 acre-feet annually for the irrigation of 250 acres within the E 1/2 of Section 5, T.4S., R.55E., M.D.B.&M.


***This certificate changes the point of diversion and place of use of a portion of Permit 19330, Certificate 6382, therefore, the date of priority remains the same as Permit 19330, Certificate 6382.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
