CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Katherine Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 22, T.3S., R.35E., M.D.B.&M.
or at a point from which the NE corner of said
Section 22 bears N. 88° 08' E., a distance of
1,300.0 feet situated in Esmeralda County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

The waters under Permits 45236, 45237, 45238 and 45239 are comingled. The total combined duty of water under any certificates issued under Permits 45236, 45237, 45238 and 45239 shall not exceed 1,128.5 acre-feet per annum.

The total combined rate of diversion granted under this certificate and any certificates granted under Permits 45236, 45237 and 45238 is limited to 2.78 c.f.s.


*This certificate changes the place of use of Permit 43236 which changed the place of use of a portion of Permit 26365, Certificate 9491, therefore, the date of priority remains the same as Permit 26365, Certificate 9491.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
