CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Chester H. Oxborrow, Trustee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE¼ NE¼ Section 6, T.1S., R.69E., M.D.B.&M. or at a point from which the SE corner of said Section 6 bears S. 11° 58' E., a distance of 2,801.0 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Chester H. and Josephine Oxborrow as Trustees for Family Trust

Source: Underground

Manner of Use: Irrigation

Amount of appropriation: 2.5 c.f.s. but not to exceed 567.15 acre-feet per season

Period of use: March 1st to November 30th of each year

Date of priority of appropriation: *July 6, 1973

Description of land to which the water is appurtenant:

The total combined rate of diversion under this certificate and any certificate issued under Permit 52000 is limited to 4.5 c.f.s.

The total combined duty of water under this certificate and any certificates issued under Permits 39270 and 48410 shall not exceed 808.65 acre-feet per season.


*This certificate changes the place of use of Permit 27586, Certificate 9764, therefore, the date of priority remains the same as Permit 27586, Certificate 9764.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per season from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
