CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gregory M. Bilyeu, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source (Well #5) through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

NW¼ SW¼ Section 4, T.16N., R.22E., M.D.B.&M. or at a point from which the SW corner of said Section 4 bears S. 4° 2' 12" W., a distance of 1,553.0 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Edward C. Allred and Charmay Allred
Source: Underground (Well #5)
Manner of Use: Irrigation and Domestic
Amount of appropriation: 6.0 c.f.s. but not to exceed 568.4 acre-feet annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: August 12, 1988

30.0 acres in the SE¼ NE¼ Section 4, T.16N., R.22E., M.D.B.&M.
18.7 acres in the SW¼ NE¼ Section 4, T.16N., R.22E., M.D.B.&M.
37.8 acres in the SE¼ NW¼ Section 4, T.16N., R.22E., M.D.B.&M.
5.9 acres in the SW¼ NW¼ Section 4, T.16N., R.22E., M.D.B.&M.
14.4 acres in the NW¼ SW¼ Section 4, T.16N., R.22E., M.D.B.&M.
11.8 acres in the NE¼ SW¼ Section 4, T.16N., R.22E., M.D.B.&M.
142.1 Acres Total

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
