CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Brent R. Woolsey, as agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Sam's Camp Spring No. 1 through a cleaned out spring, collection box, distribution system and stockwatering troughs for stockwater and wildlife purposes. The point of diversion of water from the source is as follows:

NW¼ NE¼ of Section 26, T.7S., R.69E., M.D.B.&M., or at a point from which the SE corner of Section 35, T.7S., R.69E., M.D.B.&M., bears S. 12° 56' 13" E., a distance of 9,630.0 feet (unsurveyed) situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Manner of Use: Stockwater and Wildlife

Amount of appropriation: 0.01292 c.f.s., or sufficient to water 900 head of cattle

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: *April 2, 1987

Description of the works of diversion, manner and place of use:

Water is diverted from Sam's Camp Spring No. 1, through a 2" PVC pipe to a collection box thence via 18 miles of 2" PVC pipe (underground lines) to stockwatering troughs located in (see attached).



*This certificate changes the place of use of Permit 50768, therefore, the date of priority remains the same as Permit 50768.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
