CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, John H. Milton III, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (North Well) through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NW¼ SW¼ Section 4, T.30N., R.35E., M.D.B.&M.,  
or at a point from which the W¼ corner of said  
Section 4 bears N. 22° 39' 35" W., a distance  
of 782.7 feet situated in Pershing County,  
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

\*The total combined rate of diversion and duty of water under any certificates issued under Permits 50920, 50922 and 50924 shall not exceed 3.90 c.f.s. and 2,023.91 acre-feet annually, respectively.

\*\*The total combined duty of water under Proofs 01322 and 03023 and any certificates issued under Permits 50917, 50919, 50920, 50921, 50922, 50923 and 50924 shall not exceed 3,813.68 acre-feet per annum.

\*\*\*This certificate changes the place of use of Permit 25663, Certificate 8807, which changed the point of diversion of Permit 21581, therefore, the date of priority remains the same as Permit 21581.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
