CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert L. Fisher, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

SE¼ NE¼ of Section 7, T.20N., R.19E.,
M.D.B.&M., or at a point from which the NE
corner of said Section 7 bears N. 16° 30' E.,
a distance of 2,130.0 feet situated in Washoe
County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Richard E. and Jessie L. Spooner
Source: Underground
Manner of Use: Quasi-Municipal
Amount of appropriation: *0.00017 c.f.s., but not to exceed
0.1258 acre-feet annually
Period of use: January 1st to December 31st of each
year
Date of priority of
appropriation: **October 14, 1957

Description of the works of diversion, manner and place of use:

Water is diverted by means of a drilled well, 310 feet deep, 8 inch diameter steel casing, equipped with a one H.P. submersible pump, thence the water is conveyed to two storage tanks, 20,000 and 11,000 gallon, which serve a building which houses offices, a mechanics shop and a truck washing operation, and landscaping all located within portions of the SE¼ NE¼ and NE¼ SE¼ Section 7, T.20N., R.19E., M.D.B.&M.


*This certificate is issued with the understanding that the total combined diversion rate and duty of water under this certificate and any certificates issued under Permit Numbers 52431, 52432, 52433, 52435 and 52436 is limited to 0.00345 c.f.s. and not to exceed 2.0 acre-feet annually.

**This certificate changes the point of diversion and place of use of a portion of Permit 34762, which changed the point of diversion, manner and place of use of a portion of Permit 17418, Certificate 5908, therefore, the date of priority remains the same as Permit 17418, Certificate 5908.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
