CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Sterling C. Ditsworth, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Well #2) through a drilled well, pump and distribution system for quasi-municipal and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 20, T.21S., R.61E., M.D.B.&M.
or at a point from which the N¼ corner of said
Section 20 bears N. 28° 59' 18" W. a distance
of 1557.75 feet situated in Clark County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator:	MR Realty
Source:	Underground (Well #2)
Manner of Use:	Quasi-Municipal and Domestic
Amount of appropriation:	0.184 c.f.s. but not to exceed 63.56 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	*February 5, 1949

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 922 feet deep, 12 inch casing via a deep well turbine pump equipped with a 50 H.P. motor, thence through a distribution system to the Dunes Hotel for use in the laundry and cooling towers and the Golf Pro Shop located in the NE¼ NE¼ of Section 20, T.21S., R.61E., M.D.B.&M.

The total combined rate of diversion granted under this certificate and Permit 27837 Certificate 8884, Permit 30702 Certificate 13746 and any certificates granted under Permit 58764 is limited to 0.84 c.f.s.

The total combined duty of water under this certificate and Permit 27838 Certificate 13116, Permit 30702 Certificate 13746, and any certificates issued under Permit 58764 shall not exceed 263.56 acre-feet annually.

*This certificate changes the point of diversion of a portion of Permit 30701 which changed the point of diversion, place of use and manner of use of a portion of Permit 12809 Certificate 5144, therefore, the date of priority remains the same as Permit 12809 Certificate 5144.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
