CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Jack D. Ferris, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (SC #2) through a drilled well, pump and distribution system for quasi-municipal and domestic purposes. The point of diversion of water from the source is as follows:

SE¼ SW¼ of Section 35, T.21N., R.20E., M.D.B.&M. or at a point from which the NW corner of Section 2, T.20N., R.20E., M.D.B.&M. bears S. 89° 52' 47" W., a distance of 1,376.03 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Washoe County
Source: Underground source (SC #2)
Manner of Use: Quasi-Municipal and Domestic
Amount of appropriation: *0.1245 c.f.s., but not to exceed 13.555 million gallons annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: **June 15, 1972

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 235 feet deep, 6 inch casing, equipped with a 10 stage pump and motor through a meter, thence conveyed through a distribution system to service 37 houses within the Spring Creek Subdivision situated within:

T.20N., R.20E., M.D.M.

*The combined duty of this certificate and any certificate issued under Permit 51477 shall not exceed 13.555 million gallons annually.



**This certificate changes the point of diversion and place of use of a portion of Permit 48033 which changed the manner and place of use of a portion of Permit 26776, Certificate 9540, therefore, the date of priority remains the same as Permit 26776, Certificate 9540.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
