CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George G. Lindesmith, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (MCO Well #2) through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NE¼ NW¼ Section 5, T.22N., R.21E., M.D.B.&M. or at a point from which the NE corner of said Section 5 bears N. 66° 17' 59" E., a distance of 2,969.86 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Tehama Holdings, Inc.
Source: Underground (MCO Well #2)
Manner of Use: Irrigation
Amount of appropriation: 0.3372 c.f.s., but not to exceed 112.40 acre-feet annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: \*May 23, 1967

Description of the land to which the water is appurtenant:

7.20 acres in the NW¼ NE¼ Section 5, T.22N., R.21E., M.D.B.&M.
0.36 acres in the SW¼ NE¼ Section 5, T.22N., R.21E., M.D.B.&M.
17.60 acres in the NE¼ NW¼ Section 5, T.22N., R.21E., M.D.B.&M.
2.94 acres in the SE¼ NW¼ Section 5, T.22N., R.21E., M.D.B.&M.
28.10 Acres Total

This certificate and any certificates issued under Permit 57087 shall have a total combined duty of 112.40 acre-feet annually.


This certificate and any certificate issued under Permits 57085, 57087, 57088, 57089, 57095, 58507, 58508 and 58509 shall have a total combined diversion rate and duty of 0.98882 c.f.s. and 405.16 acre-feet annually.

\*This certificate changes the place and manner of use of a portion of Permit 28446, Certificate 8633, which changed the point of diversion of Permit 27668 which changed the point of diversion and place of use of a portion of Permit 23888, Certificate 8283, therefore, the date of priority remains the same as Permit 23888.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
