CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George G. Lindesmith, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Well WT-1) through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 08, T.22N., R.21E., M.D.B.&M., or at a point from which the NW corner of said Section 8 bears N. 54° 28' 00" W., a distance of 4,600.00 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Fahnestock Enterprises, Inc.

Source: Underground (Well WT-1)

Manner of Use: Irrigation and Domestic

Amount of appropriation: *0.746 c.f.s., but not to exceed 540.0 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: **September 9, 1969

Description of the land to which water is appurtenant:

6.2 acres in the SW¼ NE¼ Section 8, T.22N., R.21E., M.D.B.&M.
 36.8 acres in the SE¼ NE¼ Section 8, T.22N., R.21E., M.D.B.&M.
 19.0 acres in the SW¼ NE¼ Section 9, T.22N., R.21E., M.D.B.&M.
 37.0 acres in the SW¼ NW¼ Section 9, T.22N., R.21E., M.D.B.&M.
36.0 acres in the SE¼ NW¼ Section 9, T.22N., R.21E., M.D.B.&M.
 135.0 Acres Total

The total combined duty under this certificate and any certificate issued under Permit 55608 shall not exceed 732.0 acre-feet annually.

*The total combined diversion rate and duty may be pumped from either the point of diversion of Permit 55600 or Permit 55608 as needed for efficient operation. This authorization ceases if all or a portion of either permit is the subject of a permanent change application.


**This certificate changes the place of use of Permit 52457 which changed the point of diversion and place of use of Permit 50514 which changed the point of diversion of Permit 31065, Certificate 10546, which changed the point of diversion of a portion of Permit 25277, Certificate 8513, therefore, the date of priority remains the same as Permit 25277, Certificate 8513.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
