CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard H. Guelich, III, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NW¼ Section 23, T.19N., R.47E., M.D.B.&M., or at a point from which the NW corner of said Section 23 bears N. 43° 41' 58" W., a distance of 1,908.59 feet situated in Lander County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Source: Underground
Manner of Use: Irrigation and Domestic
Amount of appropriation: 4.99 c.f.s., but not to exceed 1,054.16 acre-feet annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: *September 8, 1972

26.89 acres in the NE¼ NW¼ Section 23, T.19N., R.47E., M.D.B.&M.
32.59 acres in the SW¼ NW¼ Section 23, T.19N., R.47E., M.D.B.&M.
30.94 acres in the SE¼ NW¼ Section 23, T.19N., R.47E., M.D.B.&M.

*This certificate changes the point of diversion of Permit 44693 which changed the point of diversion of Permit 26959, therefore, the date of priority remains the same as Permit 26959.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
