CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Katherine A. Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

Lot 1 (NE¼ NE¼) Section 3, T.13N., R.25E., M.D.B.&M., or at a point from which the NW corner of said Section 3 bears N. 77° 00' W., a distance of 5,400.0 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Edna Jane Sceirine, David Sceirine and Joseph Sceirine

Source: Underground

Manner of Use: Irrigation

Amount of appropriation: 1.963 c.f.s., but not to exceed 593.77 acre-feet per season

Period of use: March 1st to October 31st of each year

Date of priority of appropriation: *May 4, 1961

Description of the land to which the water is appurtenant:

40.00 acres in the NW¼ SW¼ Section 27, T.14N., R.25E., M.D.B.&M.
 29.10 acres in the NE¼ SW¼ Section 27, T.14N., R.25E., M.D.B.&M.
 34.02 acres in the SW¼ SW¼ Section 27, T.14N., R.25E., M.D.B.&M.
 33.90 acres in the SE¼ SW¼ Section 27, T.14N., R.25E., M.D.B.&M.
 23.16 acres in the NW¼ SE¼ Section 27, T.14N., R.25E., M.D.B.&M.
 12.62 acres in the NE¼ SE¼ Section 27, T.14N., R.25E., M.D.B.&M.
 172.80 Acres Total

The entire 172.80 acres under this certificate is supplemental to Claim No. 142 of the Final Decree in United States v. Walker River Irrigation District, In Equity, Docket No. C-125 (D. Nevada 1936).

*This certificate changes the point of diversion and place of use of Permit 19828, Certificate 6097, therefore, the date of priority remains the same as Permit 19828, Certificate 6097.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
