CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Armond Hamlett, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE¼ SE¼ Section 23, T.12N., R.25E., M.D.B.&M., or at a point from which the SE corner of said Section 23 bears S. 03° 05' E., a distance of of 1324.0 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

341.75 acres Total

\*The total combined duty under this certificate and any issued under Permits 56594, 56595, 56596, 56597 and 56599 shall not exceed 1367.0 acre-feet annually.

\*\*This certificate changes the place of use of Permit 50578 which changed the point of diversion and place of use of a portion of Permit 43668 which changed the place of use of a portion of Permit 18681 Certificate 6005, therefore, the date of priority remains the same as Permit 18681 Certificate 6005.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
