CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Perry Williams, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a vertical culvert, pump and distribution system for Mining and Milling purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 3, T.7S., R.40E., M.D.B.&M.,
or at a point from which the SW corner of said
Section 3, bears S. 79°35'37" W., a distance
of 3230.34 feet situated in Esmeralda County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a 36 inch diameter buried culvert, placed vertically between bedrock and the surface, via a 14 H.P. Flyght submersible pump, thence water is conveyed through an 8 inch discharge hose to a 150 yard per hour Trommel for placer mining and milling at the Tule Canyon Mine located within the following:


