CERTIFICATE OF APPROPRIATION OF WATER

- - - - -

WHEREAS, John R. Harmon, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground source through a drilled well, pump and distribution system for Irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 16, T.30N., R.35E., M.D.B.&M.
or at a point from which the SW corner of said
Section 16 bears S. 47°00'00" E., a distance
of 67.00 feet situated in Pershing County,
State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	0.30 f.s., but not to exceed 105.70 acre-feet annually
Period of use:	January 1st to December 31st of each year

*The total combined rate of diversion and duty of water under this certificate and any certificates issued under Permits 58570, 58571 and 58573 shall not exceed 2.0 c.f.s. and 633.90 acre-feet annually, respectively.

*The total combined duty of water under this certificate and Permit 29524 Certificate 10682, Permit 43403 Certificate 10698, Permit 43404 Certificate 13375, Permit 43405 Certificate 10699, Permit 43406 Certificate 13376, Permit 47736 Certificate 13377 and any certificates issued under Permits 58570, 58571 and 58573 shall not exceed 1,081.52 acre-feet annually.

**This certificate changes the point of diversion and place of use of a portion of Permit 47736, which changed the point of diversion of a portion of Permit 43406, which changed the point of diversion of a portion of Permit 29524, therefore, the date of priority remains the same as Permit 29524.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre feet per acre per annum from any/or all sources.
