CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Richard W. Arden, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Well #1) through a drilled well, pump and center pivot for Irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 24, T.3S., R.54E., M.D.B.&M., or at a point from which the SW corner of said Section 24 bears S. 66°54'31" W., a distance of 272.28 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Penoyer Farms, Ltd.
 Source: Underground (Well #1)
 Manner of Use: Irrigation
 Amount of appropriation: *1.32 c.f.s., but not to exceed 52.0 acre-feet per season
 Period of use: March 1st to November 30th of each year
 Date of priority of appropriation: **February 13, 1964

*The total combined rate of diversion granted under this certificate and Permit 36437, Certificate 13482; Permit 36440, Certificate 13483; Permit 42570, Certificate 13500 and any certificate issued under Permit 56329 is limited to 2.07 c.f.s.

*The water under this certificate and Permit 36437, Certificate 13482; Permit 36440, Certificate 13483; and Permit 42570, Certificate 13500 and any certificate issued under Permit 56329 is comingled and the total duty of water shall not exceed 573.71 acre-feet annually for the irrigation of 125 acres within the SW $\frac{1}{4}$ of Section 24, T.3S., R.54E., M.D.B.&M.

**This certificate changes the point of diversion and place of use of Permit 44225, which changed the point of diversion and place of use of a portion of Permit 23710, Certificate 6375, which changed the point of diversion of Permit 21812, therefore, the date of priority remains the same as Permit 21812.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
