CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Bruce L. Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 33, T.14N., R.25E., M.D.B.&M., or at a point from which the SW corner of said Section 33 bears S. 87°59' W., a distance of 1,910.0 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*The total combined duty of water under this certificate and any certificates issued under Permits 45856, 53913, and 56856 shall not exceed 2,631.0 acre-feet annually.

**This certificate changes the point of diversion and place of use of Permit 45857, which changed the point of diversion, place of use and manner of use of Permit 23048, Certificate 7528, therefore, the date of priority remains the same as Permit 23048, Certificate 7528.

This certificate is issued supplemental to Walker River Decreed and Storage Rights.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
