CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Joseph E. Roderick, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground source through a drilled well, pump and irrigation system for Irrigation purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 1, T.12N., R.25E., M.D.B.&M., or at a point from which the NE corner of said Section 1, bears N. 10°31'55" E., a distance of 4,023.49 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Amount of appropriation: 2.70 c.f.s., but not to exceed *576.0 acre-feet seasonally


*The total combined duty of water under this certificate and any certificate issued under Permit 58482 shall not exceed 886.0 acre-feet seasonally.

**This certificate changes the place of use and manner of use of Permit 18815 Certificate 5413, therefore, the date of priority remains the same as Permit 18815 Certificate 5413.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per year for any one year.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
