CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Michael D. Buschelman, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from the Truckee River (Highland Ditch) through pumps, pipelines, and a sprinkler system for recreation (golf course) purposes. The point of diversion of water from the source is as follows:

NW $\frac{1}{4}$ , NE $\frac{1}{4}$  Section 16, T.19N., R.18E., M.D.B.&M., or at a point from which the NE corner of said Section 16 bears N. 75°16' E., a distance of 1,650.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Washoe County  
 Source: Truckee River (Highland Ditch)  
 Manner of Use: Recreation (Golf Course)  
 Amount of appropriation: \*0.15 c.f.s., but not to exceed 35.20 acre feet per season as decreed  
 Period of use: As Decreed  
 Date of priority of appropriation: \*\*April 1, 1872

Description of the works of diversion, manner and place of use:

Water is diverted from an existing structure into Highland Ditch and conveyed to a lift station at the ditch. A 200 H.P. deep well turbine lift pump conveys water to a 26 AF Reservoir (Permit J-246) through a 10 inch pipe. The lift station is equipped with a 10 inch McCrometer totalizing meter. The reservoir's main pumphouse is equipped with two 100 H.P., one 25 H.P., and one 40 H.P. Jockey pump(s) which pump 2,000 gpm to Northgate Golf Course through pipelines and a sprinkler system. The land to which the water is appurtenant is:

\*The total combined duty of water under this certificate and any certificates issued under Permits 50830, 51568, and 51569 shall not exceed 285.22 acre feet per season as decreed.

\*\*This certificate changes the point of diversion, place of use and manner of use of a portion of Truckee River Claim No. 326, Final Decree in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D.Nevada 1944), therefore, the date of priority remains the same as Claim No. 326.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
