**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, James P. Wallace, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and sprinkler system for irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 15, T.4S., R.36E., M.D.B.&M., or at a point from which the W $\frac{1}{4}$  corner of said Section 15 bears S. 88°37' W., a distance of 1,250.0 feet situated in Esmeralda County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Source: Underground  
 Manner of Use: Irrigation  
 Amount of appropriation: \*0.48 c.f.s., but not to exceed 107.30 acre feet annually  
 Period of use: January 1st to December 31st of each year

\*The total combined rate of diversion and duty of water under this certificate and any certificates issued under Permits 55732 and 55734 shall not exceed 3.28 c.f.s. and 614.60 acre feet annually, respectively.

\*\*This certificate changes the point of diversion and place of use of a portion of Permit 36328, Certificate 11425, which changed the point of diversion of Permit 28814, therefore, the date of priority remains the same as Permit 28814.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
