CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Steve Varela, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from the Truckee River (Boynton Slough) through a pump station and sprinkler system for recreation (golf course) purposes. The point of diversion of water from the source is as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 22, T.19N., R.20E., M.D.B.&M., or at a point from which the W $\frac{1}{4}$ corner of said Section 22 bears N. 73°30' W., a distance of 1,910.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: City of Reno
 Source: Truckee River (Boynton Slough)
 Manner of Use: Recreation (Golf Course)
 Amount of appropriation: *1.65 c.f.s., but not to exceed 264.0 acre-feet annually as decreed
 Period of use: As Decreed
 Date of priority of appropriation: **1873

Description of the works of diversion, manner and place of use:

Water is diverted by means of a pump station equipped with one 25 H.P., one 50 H.P., and one 60 H.P. Turbine pumps, thence through a sprinkler system to the Rosewood Lakes Golf Course located within the following:



**This certificate changes the point of diversion, place of use, and manner of use of a portion of Truckee River Claim 486, Final Decree in United States v. Orr Water Ditch Co., In Equity Docket No. A-3 (D. Nevada 1944), therefore, the date of priority remains the same as Claim 486.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
