CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Robert R. Squires, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Reno H.S. well) through a drilled well, pump, and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

NE 1/4 NE 1/4 Section 15, T.19N., R.19E., M.D.B.&M., or at a point from which the NE corner of said Section 15 bears N. 67°10'00" E., a distance of 1,047.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Sun Valley Water and Sanitation District, and Washoe County

Source: Underground (Reno H.S. well)

Manner of Use: Quasi-Municipal

Amount of appropriation: 0.0967 c.f.s., but not to exceed 70.0 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: \*January 25, 1956

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 420 feet deep, 16 inch diameter casing, via a Peabody Floway pump equipped with a 300 H.P. G.E. motor, thence through Sierra Pacific Power Company's distribution system to Sun Valley located within the W 1/2, NW 1/4 NE 1/4, S 1/2 NE 1/4 of Section 8, T.20N., R.20E., M.D.B.&M. and the E 1/2 of Section 17, T.20N., R.20E., M.D.B.&M. excepting therefrom the 10+ acres belonging to Washoe County School District situated in the NW 1/4 NW 1/4 of the E 1/2 of said Section 17.

\*This certificate changes the point of diversion, manner of use, and place of use of a portion of Permit 16844, Certificate 4542, therefore, the date of priority remains the same as Permit 16844, Certificate 4542.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
