CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, James A. Linebaugh, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Stinson Well) through a drilled well, pump, storage tank and watering trough for stockwater purposes. The point of diversion of water from the source is as follows:

NE 1/4 SE 1/4 Section 11, T.10N., R.35E., M.D.B.&M., or at a point from which the SW corner of Section 33, T.11N., R.35E., M.D.B.&M. bears N. 17°16' W., a distance of 13,558.00 feet situated in Mineral County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Jack W. Estill Trust (40%), Jewell Estill Trust (40%), Roger K. Vehrs (20%), dba Rawhide Ranch
Source: Underground (Stinson Well)
Manner of Use: Stockwater
Amount of appropriation: *0.022 c.f.s., or sufficient to water 1,000 head of cattle and 12 horses
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: December 1, 1993

Description of the works of diversion, manner and place of use:

The water is developed by a drilled well, 291 feet deep with 6 inch diameter casing, via a 3/4 H.P. submersible pump powered by a diesel generator into a large storage tank, thence water is trucked to troughs where 1,000 head of cattle and 12 horses water within the S 1/2 Sections 11 and 12 and within Sections 13, 14, 23, 24, 25, 26, 35, and 36, T.10N., R.35E., and within Sections 1 and 2, T.9N., R.35E., M.D.B.&M., located within the Pilot-Table Mountain Allotment.

*The total combined duty of water under this certificate and any certificates issued under Permits 59415, 59416, 59417, 59418, and 59419 shall not exceed 0.032 c.f.s. or that which is sufficient to water 1,000 head of cattle and 12 horses.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
