CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, William A. Nisbet, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Rachel Pivot) through a drilled well, pump, and sprinkler system for irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 2, T.4S., R.55E., M.D.B.&M., or at a point from which the NE corner of Section 35, T.3S., R.55E., M.D.B.&M., bears N. 11°55'26" E., a distance of 6,890.26 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: R. Dirk Agee and Marta S. Agee  
Source: Underground (Rachel Pivot)  
Manner of Use: Irrigation  
Amount of appropriation: 1.205 c.f.s., but not to exceed 487.5 acre-feet annually  
Period of use: January 1st to December 31st of each year  
Date of priority of appropriation: \*April 5, 1977

Description of land to which the water is appurtenant:


32.5 acres in Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Sec. 2, T.4S., R.55E., M.D.B.&M.  
32.5 acres in Lot 2 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Sec. 2, T.4S., R.55E., M.D.B.&M.  
32.5 acres in the (SW $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Sec. 2, T.4S., R.55E., M.D.B.&M.  
97.5 acres total.

\*This certificate changes the place of use of a portion of Permit 45085, Certificate 12236, which changed the point of diversion and place of use of a portion of Permit 31281, therefore, the date of priority remains the same as Permit 31281.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
