CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Alice Beth Robison, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 20, T.20N., R.64E., M.D.B.&M., or at a point from which the N $\frac{1}{4}$ corner of said Section 20 bears N. 16°22'00" E., a distance of 1,412.39 feet situated in White Pine County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*The total combined duty of water under this certificate and Permit 24315, Certificate 7850, Permit 30257, Certificate 12218, Permit 35560, Certificate 12219, and any certificates issued under Permits 30258 and 48702 shall not exceed 731.80 acre-feet annually.

**This certificate changes the point of diversion of a portion of Permit 32102. Therefore, the date of priority remains the same as Permit 32102.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
