Donnelly, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (Well No. 69) through a drilled well, pump, and distribution system for municipal and domestic purposes. The point of diversion of water from the source is as follows:

SE¼ SE¼ Section 9, T.20S., R.60E., M.D.B.&M., or at a point from which the SE corner of said Section 9 bears S. 27°20'40" E., a distance of 275.71 feet situated in Clark County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Description of the works of diversion, manner and place of use:

Water is developed by means of a drilled well, 1,143 feet deep, 20 inch casing, via a deep well pump to pipelines and reservoirs, thence through a distribution system to the area included within the boundaries of the Las Vegas Valley Water District as denoted by Chapter 167, Statutes of Nevada, 1947, as it now exists or as it may hereafter be amended for municipal and domestic purposes.

*This certificate changes the point of diversion and manner of use of a portion of Permit 40267, Certificate 11104, which changed the point diversion and place of use and manner of use of a portion of Permit 20182, Certificate 5782, therefore, the date of priority remains the same as Permit 20182, Certificate 5782.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.


