CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, William A. Nisbet, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source (West Pivot) through a drilled well, pump, and sprinkler system for irrigation purposes. The point of diversion of water from the source is as follows:

SW¼ SE¼ Section 33, T.3S., R.55E., M.D.B.&M., or at a point from which the SE corner of said Section 33 bears S. 45°08' E., a distance of 1,871.0 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: R. Dirk Agee and Marta S. Agee

Source: Underground (West Pivot)

Manner of Use: Irrigation

Amount of appropriation: *2.365 c.f.s., but not to exceed 400.0 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: **April 5, 1977

Description of land to which the water is appurtenant:

33.375 acres in the NW¼ SE¼ of Sec. 33, T.3S., R.55E., M.D.B.&M.
 33.375 acres in the NE¼ SE¼ of Sec. 33, T.3S., R.55E., M.D.B.&M.
 33.375 acres in the SW¼ SE¼ of Sec. 33, T.3S., R.55E., M.D.B.&M.
 33.375 acres in the SE¼ SE¼ of Sec. 33, T.3S., R.55E., M.D.B.&M.
 133.500 acres total.

*The water under this certificate and any certificates issued under Permits 58421 and 58422 are comingled and the place of use is limited to 133.50 acres; the total combined rate of diversion and duty of water is limited to 3.045 c.f.s. and 667.50 acre-feet annually.


**This certificate changes the point of diversion, and place of use, and manner of use of Permit 31281, Certificate 10867, therefore, the date of priority remains the same as Permit 31281, Certificate 10867.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
