CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, John H. Milton III, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Rose Creek through a diversionary structure, pipeline, and sprinklers for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NW¼ SE¼ Section 2, T.34N., R.36E., M.D.B.&M., or at a point from which the NE corner of said Section 2 bears N. 21°15'00" E., a distance of 3,590.0 feet situated in Pershing County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Source: Rose Creek
 Manner of Use: Irrigation and Domestic
 Amount of appropriation: *2.50 c.f.s., but not to exceed 399.20 acre-feet
 Period of use: January 1st to December 31st of each year
 Date of priority of appropriation: **June 11, 1974

*The water under this certificate and any certificate issued under Permit 38831 is commingled and the total combined duty of water shall not exceed 459.20 acre-feet annually.


**This certificate changes the place of use of Permit 31047, which changed the place of use of a portion of Permit 28407, therefore, the date of priority remains the same as Permit 28407.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
