CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Rick P. Christian, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an unnamed spring through pipes, ditches, and a distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

Lot 2 (NW¼ NE¼) Section 03, T.27N., R.23E., M.D.B.&M., or at a point from which the SE corner of Section 34, T.28N., R.23E., M.D.B.&M., bears N. 79°44'52" E., a distance of 1,927.14 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: James D. and Ann M. Santini, Robert B. and Mia K. Morrill, and Morris C. and Mary L. Royals

Source: Unnamed Spring

Manner of Use: Irrigation and Domestic

Amount of appropriation: *0.04 c.f.s., but not to exceed 28.96 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: August 12, 1993



The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
