**CERTIFICATE OF APPROPRIATION OF WATER**

WHEREAS, Charles W. Muncy, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and distribution system for recreation (golf course) purposes. The point of diversion of water from the source is as follows:

**SW¼ SE¼ Section 31, T.20S., R.60E., M.D.B.&M., or at a point from which the SW corner of said Section 31 bears S. 76°07'40" W., a distance of 3,215.95 feet situated in Clark County, State of Nevada.**

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: **Senior Tour Players Development, Inc.**  
 Source: **Underground**  
 Manner of Use: **Recreation (golf course)**  
 Amount of appropriation: **\*0.25 c.f.s., but not to exceed 176.40 acre feet annually**  
 Period of use: **January 1st to December 31st of each year**  
 Date of priority of appropriation: **\*\*March 29, 1949**

**Description of the works of diversion, manner and place of use:**

Water is developed by means of a drilled well, 894 feet deep, 14 inch diameter casing, via a 125 HP submersible pump, thence through a distribution system to the Badlands Golf Course for recreation purposes. The following acreage is irrigated:


\*The total duty of water under this certificate and any certificates issued under Permits 60739, 60740, and 60742 is limited to 399.0 acre feet annually.

\*\*This certificate changes the point of diversion, place of use and manner of use of Permit 56682, which changed the point of diversion, place of use and manner of use of a portion of Permit 29277, Certificate 10490, which changed the point of diversion of Permit 18263, Certificate 5607, which changed the point of diversion, place of use and manner of use of a portion of Permit 12869, therefore, the date of priority remains the same as Permit 12869.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
