CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gregory M. Bilyeu, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Musgrove Creek and Tributaries through a pond and thence pumped to a 325 gallon holding tank and sprinklers for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE¼ SW¼ Section 22, T.16N., R.19E., M.D.B.&M., or at a point from which the S¼ corner of said Section 22 bears S. 25°42'00" E., a distance of 2,462.24 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: John H. Sheldon and Bernice W. Sheldon, Co-Trustees of the Sheldon Family Trust

Source: Musgrove Creek and Tributaries

Manner of Use: Irrigation and Domestic

Amount of appropriation: 0.029 c.f.s., but not to exceed 5.0 acre feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: *Prior to 1870

Description of the land to which the water is appurtenant:

The total combined duty of water under this certificate and any certificates issued under Permits 58723, 58725, and 58960, shall not exceed 5.0 acre-feet annually. All surface waters must be used for irrigation prior to the use of any of the supplemental groundwater.


*This certificate changes the point of diversion, manner and place of use of a portion of Permit 50071, Certificate 12436, which changed the point of diversion of Proof 02540 of the Musgrove Creek Decree, (In the District Court of the Second Judicial District of the State of Nevada, in and for the County of Washoe), therefore, the date of priority remains the same as Proof 02540,

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
