CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Bruce L. Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE¼ NW¼ Section 23, T.12N., R.25E., M.D.B.&M., or at a point from which the C¼ corner of said Section 23 bears S. 05°49'36" E., a distance of 545.67 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Silverado, Inc.
 Source: Underground
 Manner of Use: Irrigation and Domestic
 Amount of appropriation: *1.25 c.f.s., but not to exceed 277.4 acre feet annually
 Period of use: January 1st to December 31st of each year
 Date of priority of appropriation: **June 8, 1960

This certificate is issued supplemental to Walker River decreed and storage rights.


**This certificate changes the point of diversion and place of use of a portion of Permit 18914, Certificate 5275, therefore, the date of priority remains the same as Permit 18914, Certificate 5275.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
