CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, John M. Wadsworth, Permittee has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

NW¼ SW¼ Section 17, T.2S., R.68E., M.D.B.&M., or at a point from which the W¼ corner of Section 8, T.2S., R.68E., M.D.B.&M. bears N. 10°32'09" W., a distance of 5,370.54 feet situated in Lincoln County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Manner of Use: Irrigation
 Amount of appropriation: 1.40 c.f.s., but not to exceed 229.16 acre feet annually
 Period of use: January 1st to December 31st of each year

The water under this certificate and any certificates issued under Permits 61612 and 61614 are comingled with a total combined duty not to exceed 889.16 acre feet per season for the irrigation of 177.832 acres.


*This certificate changes the place of use of Permit 48831, which changed the point of diversion and place of use of Permit 28086. The date of priority was established in accordance with NRS 533.395(3) by the cancellation rescission hearing of Permit 48831 on November 21, 1989.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
