CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Bruce L. Rice, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump and distribution system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SW¼ NE¼ Section 11, T.11N., R.25E., M.D.B.&M., or at a point from which the NE corner of said Section 11 bears N. 54°16'52" E., a distance of 2,389.48 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: **Forrest G. Godde 1998 Trust**

Source: **Underground**

Manner of Use: **Irrigation and Domestic**

Amount of appropriation: ***0.122 c.f.s., but not to exceed 88.03 acre feet annually**

Period of use: **January 1st to December 31st of each year**

Date of priority of appropriation: ****August 13, 1976**

*The total combined duty of water under this certificate and any certificates issued under Permits 49250, 54419, and 57261 shall not exceed 954.36 acre-feet annually.

**This certificate changes the point of diversion of Permit 54420, which changed the place of use of a portion of Permit 30518, therefore, the date of priority remains the same as Permit 30518.


This certificate is also issued supplemental to Walker River Storage Rights (Topaz Reservoir) and is only valid as long as the storage rights remain appurtenant to the place of use under this certificate.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
