CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, George M. Thiel, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a submersible pump thence through a distribution system of sprinklers and a drip system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

SE¼ SW¼ Section 22, T.16N., R.19E., M.D.B.&M. or at a point from which the SW corner of said Section 22 bears S. 54°10" W., a distance of 1,790.0 feet situated in Washoe County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Thomas Di Loreto and Susan Di Loreto Family Trust

Source: Underground

Manner of Use: Irrigation and Domestic

Amount of appropriation: *0.0063 c.f.s., but not to exceed 4.556 acre-feet annually

Period of use: January 1st to December 31st of each year

Date of priority of appropriation: **August 20, 1962

*The total combined duty of water under this certificate and any certificates issued under Permits 59014, 59016, 59017, and 59018 shall not exceed 5.0 acre-feet annually. All surface waters must be used for irrigation prior to the use of any of the supplemental groundwater.


**This certificate changes the point of diversion and place of use of a portion of Permit 20648, Certificate 6086, therefore, the date of priority remains the same as Permit 20648, Certificate 6068.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from and and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
