CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gary Garms, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source through a drilled well, pump, and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SE¼ SE¼ Section 28, T.11N., R.24E., M.D.B.&M., or at a point from which the SE corner of said Section 28 bears S. 86°08'21" E., a distance of 876.26 feet situated in Lyon County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

 Amount of appropriation: *0.037 c.f.s., but not to exceed 4.74 acre-feet per season
 Period of use: April 1st to October 31st of each year

*The total combined duty of water under this certificate and Permit 60814, Certificate 14794, and any certificates issued under Permits 63461, 63462, and 63463, shall not exceed 585.0 acre-feet annually for the irrigation of 146.252 acres.


**This certificate changes the point of diversion and place of use of Permit 60722, which changed the point of diversion and place of use of a portion of Permit 16629, Certificate 5318, therefore, the date of priority remains the same as Permit 16629, Certificate 5318.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
