CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Ross E. de Lipkau, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from Lake Tahoe, through an intake, pumps and distribution system for quasi-municipal purposes. The point of diversion of water from the source is as follows:

Lake Tahoe

SE¼ NW¼ Section 10, T.14N., R.18E., M.D.B.&M., or at a point from which the meander corner common to Sections 3 and 10, T.14N., R.18E., M.D.B.&M., bears N. 10°08'00" E., a distance of 2,078.0 feet situated in Douglas County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Glenbrook Water Cooperative
Source: Lake Tahoe
Manner of Use: Quasi-Municipal
Amount of appropriation: *0.281 c.f.s., but not to exceed 30.48 million gallons annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: **1872

Description of the works of diversion, manner and place of use:

Water is diverted by means of an 1800 foot long, 12 inch diameter intake line equipped with two 100 H.P. turbine pumps and two 25 H.P. submersible pumps to an ozone water treatment plant, thence through a distribution system which serves approximately 207 single family units, 68 townhouses, 1 restaurant and 1 real estate office located within the SW¼ SW¼, Section 2; the SW¼ NE¼, SE¼ SE¼, NW¼ SE¼, NE¼ SW¼, Lot 4, and Lot 5, Section 3; NE¼ NE¼, SE¼ SE¼, Lot 1, Lot 2, Lot 3, Lot 4, and Lot 5, Section 10; SW¼, W¼ NW¼, Section 11; NW¼ NW¼, Section 14, NE¼ NE¼, portion of W¼ NE¼, and a portion of Lot 1, Section 15, all in T.14N., R.18E., M.D.B.&M.

*The total combined duty of water under this certificate and any certificates issued under Permits 61616, 61618, 61619, and 61624 shall not exceed 91.36 million gallons annually.

**This certificate changes the point of diversion and place of use of Permit 52274, which changed the point of diversion, place of use and manner of use of a portion of Claim 02148, In the Matter of the Determination of the Relative Rights of Claimants and Appropriators in and to the Waters of Glenbrook Creek and its Tributaries, In Douglas County, Nevada, Case No. 859, First Judicial Court of the State of Nevada, In and for the County of Douglas, September 19, 1941, therefore, the date of priority remains the same as Claim 02148.

This certificate is issued subject to the terms of the permit.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
