CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Lisle Lowe, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and sprinkler system for irrigation and domestic purposes. The point of diversion of water from the source is as follows:

NE¼ SW¼ Section 23, T.16S., R.48E., M.D.B.&M., or at a point from which the SW corner of said Section 23 bears S. 44°21'58" W., a distance of 1,893.0 feet situated in Nye County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Name of appropriator: Geneerco, Inc.
Source: Underground
Manner of Use: Irrigation and Domestic
Amount of appropriation: \*0.957 c.f.s., but not to exceed 94.50 acre-feet annually
Period of use: January 1st to December 31st of each year
Date of priority of appropriation: \*\*December 17, 1971

Description of land to which the water is appurtenant:

27.99 acres in the NW¼ SW¼ of Section 23, T.16S., R.48E., M.D.B.&M.
27.99 acres in the NE¼ SW¼ of Section 23, T.16S., R.48E., M.D.B.&M.
27.99 acres in the SW¼ SW¼ of Section 23, T.16S., R.48E., M.D.B.&M.
27.99 acres in the SE¼ SW¼ of Section 23, T.16S., R.48E., M.D.B.&M.
111.96 acres total

\*The water under this certificate and any certificates issued under Permits 62918, 62919, 63151, 63152 and 63153 is commingled and shall not exceed 559.80 acre-feet annually for the irrigation of 111.96 acres.

\*\*This certificate changes the point of diversion and place of use of Permit 26442, Certificate 8780, therefore, the date of priority remains the same as Permit 26442, Certificate 8780.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
