CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Gary L. Bengochea, Agent, has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an underground source, through a drilled well, pump and distribution system for irrigation purposes. The point of diversion of water from the source is as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 29, T.39N., R.37E., M.D.B.&M., or at a point from which the NW corner of Section 30, T.39N., R.37E., M.D.B.&M., bears N. 52°55'00" W., a distance of 6,801.0 feet situated in Humboldt County, State of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

Amount of appropriation:	*1.11 c.f.s., but not to exceed 244 acre-feet annually
Period of use:	January 1st to December 31st of each year
Date of priority of appropriation:	**March 23, 1971

Description of land to which the water is appurtenant:

30.5 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, T.39N., R.37E., M.D.B.&M.
 30.5 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, T.39N., R.37E., M.D.B.&M.
 30.5 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, T.39N., R.37E., M.D.B.&M.
 30.5 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 29, T.39N., R.37E., M.D.B.&M.
 122.0 acres total

*The total combined duty of water under this certificate and any certificate issued under Permit 63467 are commingled and shall not exceed 488 acre-feet annually for the irrigation of 122 acres.

**This certificate changes the point of diversion and place of use of Permit 43717, which changed the point of diversion of a portion of Permit 34814, Certificate 9511, which changed the point of diversion and place of use of Permit 30065, which changed the point of diversion of Permit 29251, which changed the point of diversion and place of use of Permit 27505, which changed the point of diversion and place of use of Permit 26014, therefore, the date of priority remains the same as Permit 26014.

This certificate is issued subject to the terms of the permit with the understanding that the total duty of water shall not exceed 4.0 acre-feet per acre per annum from any and/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
